

THE BLOW-UP OF CRITICAL ANISOTROPIC EQUATIONS WITH CRITICAL DIRECTIONS

JÉRÔME VÉTOIS

ABSTRACT. We investigate blow-up theory for doubly critical anisotropic problems in bounded domains of the Euclidean space.

1. INTRODUCTION

Anisotropic operators modelize directionally dependent phenomena. In this paper, we consider problems posed on domains in the Euclidean space \mathbb{R}^n in dimension $n \geq 2$, and we provide ourselves with an anisotropic configuration $\vec{p} = (p_1, \dots, p_n)$ with $p_i > 1$ for all $i = 1, \dots, n$. We define the anisotropic Laplace operator $\Delta_{\vec{p}}$ by

$$\Delta_{\vec{p}} u = \sum_{i=1}^n \frac{\partial}{\partial x_i} \nabla_{x_i}^{p_i} u, \quad (1.1)$$

where $\nabla_{x_i}^{p_i} u = |\partial u / \partial x_i|^{p_i-2} \partial u / \partial x_i$ for all $i = 1, \dots, n$. Nonlinear equations of the type $\Delta_{\vec{p}} u = f(\cdot, u)$ appear in several places in the literature. They appear, for instance, in biology, see Bendahmane–Karlsen [11] and Bendahmane–Langlais–Saad [13], as a model describing the spread of an epidemic disease in heterogeneous environments. They also emerge, see Antontsev–Díaz–Shmarev [5] and Bear [10], from the mathematical description of the dynamics of fluids with different conductivities in different directions.

We consider anisotropic problems of critical growth of the type

$$\begin{cases} -\Delta_{\vec{p}} u = \lambda |u|^{p^*-2} u + f(\cdot, u) & \text{in } \Omega, \\ u \in D^{1, \vec{p}}(\Omega), \end{cases} \quad (1.2)$$

where $\Delta_{\vec{p}}$ is as in (1.1), Ω is a domain of \mathbb{R}^n , $D^{1, \vec{p}}(\Omega)$ is the anisotropic Sobolev space defined as the completion of the vector space of all smooth functions with compact support in Ω with respect to the norm $\|u\|_{D^{1, \vec{p}}(\Omega)} = \sum_{i=1}^n \|\partial u / \partial x_i\|_{L^{p_i}(\Omega)}$, p^* is the critical Sobolev exponent (see (1.4) below), λ is a positive real number, and f is a Caratheodory function in $\Omega \times \mathbb{R}$ satisfying the growth condition

$$|f(\cdot, u)| \leq C (|u|^{q-1} + 1) \quad \text{a.e. in } \Omega \quad (1.3)$$

for some real number q in $(1, p^*)$ and for some positive constant C independent of u .

We are concerned with the doubly critical situation $p_+ = p^*$, where $p_+ = \max(p_1, \dots, p_n)$ is the maximum value of the anisotropic configuration and p^* is as above the critical Sobolev exponent for the embeddings of the anisotropic Sobolev space $D^{1, \vec{p}}(\Omega)$ into Lebesgue spaces. In this setting, not only the nonlinearity has critical growth, but the operator itself has critical growth in particular directions of the Euclidean space. As a remark, the notion of critical direction is a pure anisotropic notion which does not exist when dealing with the Laplace

operator or the p -Laplace operator. Given $i = 1, \dots, n$, the i -th direction is said to be critical if $p_i = p^*$, resp. subcritical if $p_i < p^*$. Critical directions induce a failure in the rescaling invariance rule associated with (1.2).

Given an anisotropic configuration \vec{p} satisfying $\sum_{i=1}^n 1/p_i > 1$ and $p_j \leq n/(\sum_{i=1}^n \frac{1}{p_i} - 1)$ for all $j = 1, \dots, n$, the critical Sobolev exponent is equal to

$$p^* = \frac{n}{\sum_{i=1}^n \frac{1}{p_i} - 1}. \quad (1.4)$$

Possible references on anisotropic Sobolev spaces are Besov [14], Hařkovec–Schmeiser [38], Kruzhkov–Kolodň [40], Kruzhkov–Korolev [41], Lu [47], Nikol'skiĭ [53], Rákosník [54, 55], and Troisi [65].

We aim in describing the asymptotic behaviors in energy space of Palais–Smale sequences associated with problem (1.2). Before stating our main result, let us fix some notations. For any $\mu > 0$ and any point $a = (a_1, \dots, a_n)$ in \mathbb{R}^n , we define the affine transformation $\tau_{\mu,a}^{\vec{p}} : \mathbb{R}^n \rightarrow \mathbb{R}^n$ by

$$\tau_{\mu,a}^{\vec{p}}(x_1, \dots, x_n) = \left(\mu^{\frac{p_1-p^*}{p_1}}(x_1 - a_1), \dots, \mu^{\frac{p_n-p^*}{p_n}}(x_n - a_n) \right). \quad (1.5)$$

As is easily checked, (1.5) provides a general rescaling invariance rule associated with problem (1.2) with $f \equiv 0$. In particular, u solves $-\Delta_{\vec{p}} u = |u|^{p^*-2} u$ in Ω if and only if the function $v = \mu^{-1} u \circ (\tau_{\mu,a}^{\vec{p}})^{-1}$ solves $-\Delta_{\vec{p}} v = |v|^{p^*-2} v$ in $\tau_{\mu,a}^{\vec{p}}(\Omega)$, where

$$(\tau_{\mu,a}^{\vec{p}})^{-1}(x_1, \dots, x_n) = \left(\mu^{\frac{p^*-p_1}{p_1}} x_1 + a_1, \dots, \mu^{\frac{p^*-p_n}{p_n}} x_n + a_n \right).$$

Given $(\mu_\alpha)_\alpha$ a sequence of positive real numbers converging to 0, $(x_\alpha)_\alpha$ a converging sequence in \mathbb{R}^n , λ a positive real number, U a nonempty, open subset of \mathbb{R}^n , and u a nontrivial solution in $D^{1,\vec{p}}(U)$ of the problem

$$\begin{cases} -\Delta_{\vec{p}} u = \lambda |u|^{p^*-2} u & \text{in } U, \\ u \in D^{1,\vec{p}}(U), \end{cases} \quad (1.6)$$

where $\Delta_{\vec{p}}$ is as in (1.1), we call \vec{p} -bubble of centers $(x_\alpha)_\alpha$, weights $(\mu_\alpha)_\alpha$, multiplier λ , domain U , and profile u , the sequence $(B_\alpha)_\alpha$ defined by

$$B_\alpha = \frac{1}{\mu_\alpha} u \circ \tau_{\mu_\alpha, x_\alpha}^{\vec{p}}$$

for all α , where $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}$ is as in (1.5). One can find existence and regularity results for problem (1.6) in Vétois [68]. In the following, we implicitly extend profiles of bubbles by 0 outside of their domains so as to regard them as functions in $D^{1,\vec{p}}(\mathbb{R}^n)$. With the above notations, we define the energy $E(B_\alpha)$ of a \vec{p} -bubble $(B_\alpha)_\alpha$ by

$$E(B_\alpha) = \sum_{i=1}^n \frac{1}{p_i} \int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx - \frac{\lambda}{p^*} \int_{\mathbb{R}^n} |u|^{p^*} dx = \sum_{i=1}^n \frac{p^* - p_i}{p^* p_i} \int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx, \quad (1.7)$$

the second equality in (1.7) being obtained by testing (1.6) with u and integrating by parts.

We approximate problem (1.2) with the problems

$$\begin{cases} -\Delta_{\vec{p}} u = \lambda_\alpha |u|^{r_\alpha-2} u + f(\cdot, u) & \text{in } \Omega, \\ u \in D^{1,\vec{p}}(\Omega), \end{cases} \quad (1.8)$$

where $\Delta_{\vec{p}}$ is as in (1.1), $(\lambda_\alpha)_\alpha$ is a sequence of positive real numbers converging to λ , and $(r_\alpha)_\alpha$ is a sequence of real numbers in $(1, p^*]$ converging to p^* . Associated with problems (1.2) and (1.8), we define the functionals I_α and I_∞ in $D^{1, \vec{p}}(\Omega)$ by

$$I_\alpha(u) = \sum_{i=1}^n \frac{1}{p_i} \int_\Omega \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx - \int_\Omega F(x, u) dx - \frac{\lambda_\alpha}{r_\alpha} \int_\Omega |u|^{r_\alpha} dx \quad (1.9)$$

and

$$I_\infty(u) = \sum_{i=1}^n \frac{1}{p_i} \int_\Omega \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx - \int_\Omega F(x, u) dx - \frac{\lambda}{p^*} \int_\Omega |u|^{p^*} dx, \quad (1.10)$$

where $F(x, u) = \int_0^u f(x, s) ds$. We say that a sequence $(u_\alpha)_\alpha$ in $D^{1, \vec{p}}(\Omega)$ is Palais–Smale for the functionals $(I_\alpha)_\alpha$ if there hold $|I_\alpha(u_\alpha)| \leq C$ for some positive constant C independent of α and $DI_\alpha(u_\alpha) \rightarrow 0$ in $D^{1, \vec{p}}(\Omega)'$ as $\alpha \rightarrow +\infty$. We say that $(u_\alpha)_\alpha$ is a bounded Palais–Smale sequence for the functionals $(I_\alpha)_\alpha$ if $(u_\alpha)_\alpha$ is moreover bounded in $D^{1, \vec{p}}(\Omega)$.

Theorem 1.1 below is referred to as a bubble tree decomposition. With this result, we provide a complete description of the asymptotic behaviors in $D^{1, \vec{p}}(\Omega)$ of bounded Palais–Smale sequences for the functionals $(I_\alpha)_\alpha$ defined in (1.9). Bubble tree decompositions were obtained by Struwe [62] for the equation $-\Delta u = u^{2^*-1}$, where Δ is the classical Laplace operator and $2^* = 2n/(n-2)$ is the critical Sobolev exponent. Related references to Struwe [62] are Brézis–Coron [17], Lions [45, 46], Sacks–Uhlenbeck [58], Schoen [60], and Wente [70]. We also refer to El Hamidi–Vétois [29] for an extension of Struwe’s result to the anisotropic Laplace operator in case $p_+ < p^*$. Here, we treat the more involved case of critical directions $p_+ = p^*$. The definition of asymptotically \vec{p} -stable domains is postponed to Section 3. Roughly speaking, asymptotically stable domains are domains which, in the limit of the rescalings, still satisfy the segment property. This notion, see El Hamidi–Vétois [29] and Vétois [67], turns out to be fundamentally associated with the question of proving bubble tree decompositions for anisotropic critical equations. We state our result as follows.

Theorem 1.1. *Let $n \geq 3$ and $\vec{p} = (p_1, \dots, p_n)$, and assume that $\sum_{i=1}^n 1/p_i > 1$ and $p_+ = p^*$. Let Ω be an asymptotically \vec{p} -stable, bounded domain of \mathbb{R}^n , and f be a Caratheodory function in $\Omega \times \mathbb{R}$ satisfying the growth condition (1.3). Let $(\lambda_\alpha)_\alpha$ be a sequence of positive real numbers converging to λ , and $(r_\alpha)_\alpha$ be a sequence of real numbers in $(1, p_+]$ converging to p_+ . For any bounded Palais–Smale sequence $(u_\alpha)_\alpha$ for the functionals $(I_\alpha)_\alpha$ defined in (1.9), there exist a solution u_∞ of problem (1.2), a natural number k , and for any $j = 1, \dots, k$, a \vec{p} -bubble $(B_\alpha^j)_\alpha$ of weights $(\mu_\alpha^j)_\alpha$ and multiplier $\tilde{\lambda}_j$ satisfying $(\mu_\alpha^j)^{p_+ - r_\alpha} \rightarrow \tilde{\lambda}_j/\lambda$ as $\alpha \rightarrow +\infty$, such that, up to a subsequence, there holds*

$$u_\alpha = u_\infty + \sum_{j=1}^k B_\alpha^j + R_\alpha \quad (1.11)$$

for all α , where $R_\alpha \rightarrow 0$ in $D^{1, \vec{p}}(\mathbb{R}^n)$ as $\alpha \rightarrow +\infty$. Moreover, there holds

$$I_\alpha(u_\alpha) = I_\infty(u_\infty) + \sum_{j=1}^k E(B_\alpha^j) + o(1) \quad (1.12)$$

as $\alpha \rightarrow +\infty$, where E , I_α , and I_∞ are as in (1.7), (1.9), and (1.10). If in addition the functions u_α are nonnegative, then u_∞ and $(B_\alpha^1)_\alpha, \dots, (B_\alpha^k)_\alpha$ are also nonnegative.

We give examples in Section 2, see Corollary 2.5, of Palais–Smale sequences which *blow up*, namely which develop at least one \vec{p} -bubble in their decompositions.

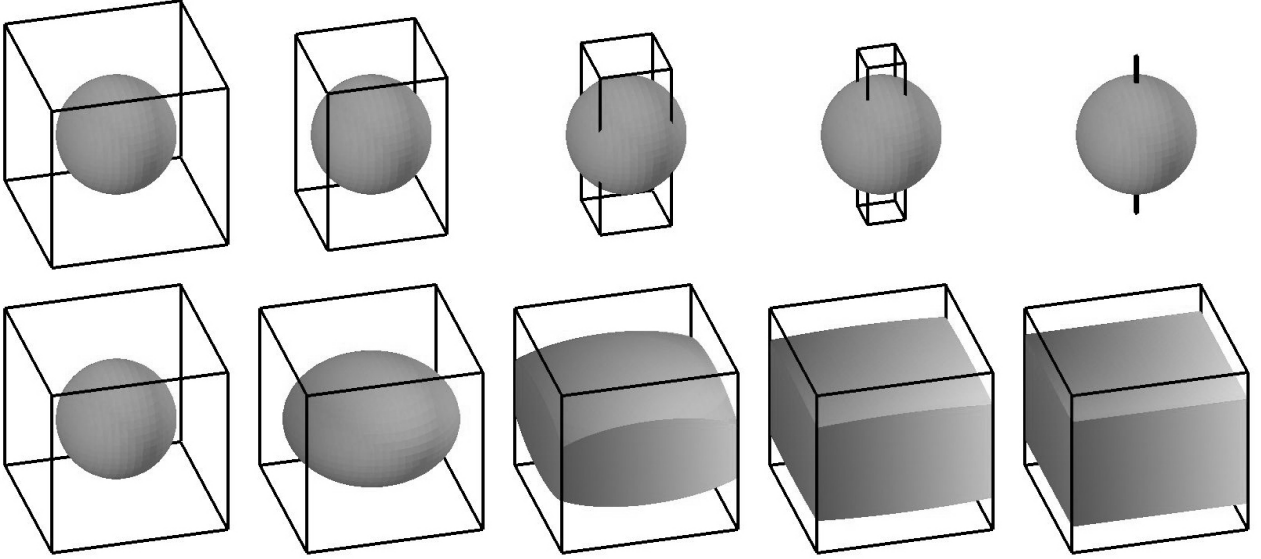


FIGURE 1. Rescaling of a ball ($n = 3$, $p_1 = p_2 = 1.5$, $p_3 = 6$). The first line describes the scale in the rescaling. The second line describes the deformation of the domain.

The analogue of Theorem 1.1 for the case $p_+ < p^*$ was established in El Hamidi–Vétois [29]. The essential difference in our doubly critical setting $p_+ = p^*$ lies in the effect of the transformation (1.5). Indeed, contrary to the case $p_+ < p^*$ where all directions are subcritical, the domain is only rescaled with respect to some directions, the noncritical ones, in case $p_+ = p^*$. Therefore, we observe a concentration phenomenon on affine subspaces of \mathbb{R}^n spanned by critical directions. For instance, Figure 1 below illustrates the rescaling of a three-dimensional ball, the first two directions being noncritical and the third direction being critical. Together with the rescaling of the domain, the equation in (1.2) is rescaled. At the limit, we find the purely invariant problem (1.6). This problem is studied in Vétois [68]. We established in [68] an existence result on cylindric domains and a general regularity result. We refer to Section 2, see Corollary 2.2, for examples of solutions of the limit problem (1.6).

As a last remark concerning the case $p_+ = p^*$, it is a borderline case for the boundedness of Palais–Smale sequences. Indeed, while any Palais–Smale sequence is bounded in case $p_+ < p^*$ for nonlinearities of the type $|u|^{r_\alpha-2}u + f(x, u)$, $r_\alpha \rightarrow p^*$ (see El Hamidi–Vétois [29]), we get examples of unbounded Palais–Smale sequences in case $p_+ > p^*$ for the nonlinearity $|u|^{p_+-2}u$ (see Fragalà–Gazzola–Kawohl [31]).

Theorem 1.1 should be seen as a general key step in the analysis of blow-up for critical anisotropic equations. We have in view the numerous applications of bubble tree decompositions which have been developed for the equation $-\Delta u = u^{2^*-1}$. Among other applications, bubble tree decompositions turn out to be key points in the use of topological arguments such as Lusternik–Schnirelmann equivariant categories. They also turn out to be key points in the analysis of ruling out bubbling and proving compactness of solutions. Possible references in book form on these subjects are Druet–Hebey–Robert [26], Ghoussoub [36], and Struwe [63].

In the isotropic configuration where $p_i = p$ for all $i = 1, \dots, n$, there holds $p < p^*$ and all directions are subcritical. In this particular situation, the operator (1.2) is comparable, though slightly different, to the p -Laplace operator $\Delta_p = \operatorname{div}(|\nabla u|^{p-2} \nabla u)$. Possible references

on critical p -Laplace equations are Alves [2], Alves–Ding [3], Arioli–Gazzola [8], Demengel–Hebey [22, 23], Filippucci–Pucci–Robert [30], Gazzola [35], Guedda–Veron [37], Saintier [59], and Yan [71]. Needless to say, the above list does not pretend to exhaustivity.

In case $p_+ < p^*$, namely when all directions are subcritical, anisotropic equations with critical nonlinearities have been investigated by Alves–El Hamidi [4], El Hamidi–Rakotoson [27, 28], El Hamidi–Vétois [29], Fragalà–Gazzola–Kawohl [31], Fragalà–Gazzola–Lieberman [32], and Vétois [67]. Other possible references on anisotropic problems like (1.1) are Antontsev–Shmarev [6, 7], Bendahmane–Karlsen [11, 12], Bendahmane–Langlais–Saad [13], Boccardo–Gallouët–Marcellini [15], Boccardo–Marcellini–Sbordone [16], Cianchi [20], D’Ambrosio [21], Di Castro [24], Di Castro–Montefusco [25], García–Melián–Rossi–Sabina de Lis [34], Kolod’ [39], Li [42], Lieberman [43, 44], Marcellini [48], Mihăilescu–Pucci–Rădulescu [50], Mihăilescu–Rădulescu–Tersian [51], Namlyeyeva–Shishkov–Skrypnik [52], Skrypnik [61], Tersenov–Tersenov [64], and Vétois [66, 68, 69].

We give examples of solutions and Palais–Smale sequences for problem (1.2) in Section 2, we discuss our geometric hypothesis on the domain Ω in Section 3, we prove a concentration result in Section 4, and we prove Theorem 1.1 in Section 5.

2. EXAMPLES OF SOLUTIONS AND PALAIS–SMALE SEQUENCES

This section is devoted to the construction of solutions and Palais–Smale sequences for problem (1.2). We begin with providing a class of examples in the situation where \vec{p} consists in two distinct exponents p_- and p_+ . In other words, we assume in the following that there exist $n_- \geq 1$ and $n_+ \geq 1$ such that $n = n_- + n_+$, $p_1 = \dots = p_{n_-} = p_-$, and $p_{n_-+1} = \dots = p_n = p_+$. Proposition 2.1 below is the basic tool in our constructions. We state our examples in Corollaries 2.2, 2.3, 2.4, and 2.5. Proposition 2.1 relies on a direct computation.

Proposition 2.1. *Let $n_- \geq 1$, $n_+ \geq 1$, $n = n_- + n_+$, and $\vec{p} = (p_1, \dots, p_n)$, and assume that $p_1 = \dots = p_{n_-} = p_-$ and $p_{n_-+1} = \dots = p_n = p_+$. Let ε and λ be two real numbers. Let $\Omega = \Omega_1 \times \Omega_2$, where Ω_1 is a nonempty, open subset of \mathbb{R}^{n_-} and Ω_2 is a nonempty, open subset of \mathbb{R}^{n_+} . Let v be a solution of the problem*

$$\begin{cases} -\sum_{i=1}^{n_-} \frac{\partial}{\partial x_i} \left(\left| \frac{\partial v}{\partial x_i} \right|^{p_- - 2} \frac{\partial v}{\partial x_i} \right) = |v|^{p_+ - 2} v + \varepsilon |v|^{p_- - 2} v & \text{in } \Omega_1, \\ v \in D^{1,p_-}(\Omega_1) \cap L^{p_+}(\Omega_1) \text{ (} \cap L^{p_-}(\Omega_1) \text{ if } \varepsilon \neq 0 \text{ and } \Omega_1 \text{ is unbounded) }, \end{cases} \quad (2.1)$$

and let w be a solution in $D^{1,\vec{p}}(\Omega_2)$ of the problem

$$\begin{cases} -\sum_{i=1}^{n_+} \frac{\partial}{\partial x_i} \left(\left| \frac{\partial w}{\partial x_i} \right|^{p_+ - 2} \frac{\partial w}{\partial x_i} \right) = \lambda |w|^{p_+ - 2} w - |w|^{p_- - 2} w & \text{in } \Omega_2, \\ w \in D^{1,p_+}(\Omega_2) \cap L^{p_-}(\Omega_2). \end{cases} \quad (2.2)$$

Then the function u defined on Ω by

$$u(x_1, \dots, x_n) = v(x_1, \dots, x_{n_-}) w(x_{n_-+1}, \dots, x_n) \quad (2.3)$$

is a solution in $D^{1,\vec{p}}(\Omega)$ of the problem

$$\begin{cases} -\Delta_{\vec{p}} u = \lambda |u|^{p_+ - 2} u + \varepsilon |u|^{p_- - 2} u & \text{in } \Omega, \\ u \in D^{1,\vec{p}}(\Omega) \cap L^{p_+}(\Omega) \text{ (} \cap L^{p_-}(\Omega) \text{ if } \varepsilon \neq 0 \text{ and } \Omega \text{ is unbounded) }. \end{cases} \quad (2.4)$$

Proof. A direct computation provides the result. \square

In case $\varepsilon = 0$, $\Omega_1 = \mathbb{R}^{n_-}$, and $\Omega_2 = \mathbb{R}^{n_+}$, see Vétois [68], we have the following corollary.

Corollary 2.2. *Let $n_- \geq 2$, $n_+ \geq 1$, $n = n_- + n_+$, and $\vec{p} = (p_1, \dots, p_n)$, and assume that $p_1 = \dots = p_{n_-} = p_-$, $p_{n_-+1} = \dots = p_n = p_+$, and $p_+ = p^*$. For any point $a = (a_1, \dots, a_n)$ in \mathbb{R}^n and for any positive real numbers μ and λ , there exists a nonnegative solution $\mathcal{U}_{a,\mu,\lambda}$ in $D^{1,\vec{p}}(\mathbb{R}^n) \cap C^1(\mathbb{R}^n)$ of problem (2.4) with $\varepsilon = 0$ and $\Omega = \mathbb{R}^n$ of the form*

$$\mathcal{U}_{a,\mu,\lambda}(x_1, \dots, x_n) = \mu^{-1} \lambda^{\frac{-1}{p_+ - p_-}} \mathcal{U}\left(\mu^{\frac{p_- - p_+}{p_-}}(x_1 - a_1), \dots, \mu^{\frac{p_- - p_+}{p_-}}(x_{n_-} - a_{n_-}), \right. \\ \left. \lambda^{\frac{1}{p_+}}(x_{n_-+1} - a_{n_-+1}), \dots, \lambda^{\frac{1}{p_+}}(x_n - a_n)\right),$$

where

$$\mathcal{U}(x_1, \dots, x_n) = \left(\frac{n_- (n_- - p_-)^{p_- - 1}}{(p_- - 1)^{p_- - 1}} \right)^{\frac{n_- - p_-}{p_-^2}} \left(\frac{1}{1 + \sum_{i=1}^{n_-} |x_i|^{\frac{p_-}{p_- - 1}}} \right)^{\frac{n_- - p_-}{p_-}} \\ \times \mathcal{W} \left(\left(\sum_{i=n_-+1}^n |x_i|^{\frac{p_+}{p_+ - 1}} \right)^{\frac{p_+ - 1}{p_+}} \right),$$

where \mathcal{W} is such that $\mathcal{W} > 0$ and $\mathcal{W}' < 0$ in $(0, R)$, and $\mathcal{W} = 0$ in $[R, +\infty)$ for some $R > 0$.

Since the function \mathcal{W} has compact support, Corollary 2.2 provides a class of solutions of the purely invariant problem (1.6) on cylindric domains $\Omega = \mathbb{R}^{n_-} \times V$ for all nonempty, open subsets V of \mathbb{R}^{n_+} .

Now, we consider the case of a bounded domain $\Omega = \Omega_1 \times \Omega_2$. Using a result by Franchi–Lanconelli–Serrin [33], we get the existence of a solution of problem (2.2) which has compact support in Ω_2 for $\lambda > 0$ large (see Vétois [68]). In order to apply Proposition 2.1, it remains to find solutions of problem (2.1).

In case $n_- \geq 3$, $p_- = 2$, and $p_+ = 2^*$, see Bahri–Coron [9], we get the existence of a nonnegative, nontrivial solution of problem (2.1) with $\varepsilon = 0$ for noncontractible, smooth, bounded domains Ω_1 . Therefore, we state a second corollary of Proposition 2.1 as follows.

Corollary 2.3. *Let $n_- \geq 3$, $n_+ \geq 1$, $n = n_- + n_+$, and $\vec{p} = (p_1, \dots, p_n)$, and assume that $p_1 = \dots = p_{n_-} = 2$, $p_{n_-+1} = \dots = p_n = 2^*$. Let $\Omega = \Omega_1 \times \Omega_2$, where Ω_1 is a nonempty, noncontractible, smooth, bounded, open subset of \mathbb{R}^{n_-} and Ω_2 is a nonempty, open subset of \mathbb{R}^{n_+} . Given a point $a = (a_1, \dots, a_n)$ in Ω_2 , for $\lambda > 0$ large, there exists a nonnegative, nontrivial solution of the form (2.3), in $D^{1,\vec{p}}(\Omega) \cap C^1(\Omega)$, of problem (2.4) with $\varepsilon = 0$.*

In case $n_- \geq 4$, $p_- = 2$, and $p_+ = 2^*$, see Brézis–Nirenberg [19], we get the existence of a nonnegative, nontrivial solution of problem (2.1) for $\varepsilon > 0$ small, on smooth, bounded domains Ω_1 . We then state a third corollary of Proposition 2.1 as follows.

Corollary 2.4. *Let $n_- \geq 4$, $n_+ \geq 1$, $n = n_- + n_+$, and $\vec{p} = (p_1, \dots, p_n)$, and assume that $p_1 = \dots = p_{n_-} = 2$, $p_{n_-+1} = \dots = p_n = 2^*$. Let $\Omega = \Omega_1 \times \Omega_2$, where Ω_1 is a nonempty, smooth, bounded, open subset of \mathbb{R}^{n_-} and Ω_2 is a nonempty, open subset of \mathbb{R}^{n_+} . Given a point $a = (a_1, \dots, a_n)$ in Ω_2 , for $\lambda > 0$ large and $\varepsilon > 0$ small, there exists a nonnegative, nontrivial solution of the form (2.3), in $D^{1,\vec{p}}(\Omega) \cap C^1(\Omega)$, of the problem (2.4).*

In case $n_- \geq 5$, see Rey [56, 57], we get the existence of families of solutions of problem (2.1) with $0 < \varepsilon \ll 1$ on smooth, bounded domains Ω_1 , which are bounded in $D^{1,2}(\Omega_1)$ and which

blow up as $\varepsilon \rightarrow 0$ at nondegenerate, critical points of the regular part of Green's function. Using this result, we state a fourth corollary of Proposition 2.1 as follows.

Corollary 2.5. *Let $n_- \geq 5$, $n_+ \geq 1$, $n = n_- + n_+$, and $\vec{p} = (p_1, \dots, p_n)$, and assume that $p_1 = \dots = p_{n_-} = 2$, $p_{n_-+1} = \dots = p_n = 2^*$. Let $\Omega = \Omega_1 \times \Omega_2$, where Ω_1 is a nonempty, smooth, bounded, open subset of \mathbb{R}^{n_-} and Ω_2 is a nonempty, open subset of \mathbb{R}^{n_+} . Let $(\varepsilon_\alpha)_\alpha$ be a sequence of positive real numbers converging to 0. Given a point $a = (a_1, \dots, a_n)$ in Ω_2 , for $\lambda > 0$ large, there exists a bounded, blowing up, Palais–Smale sequence for the functional I_∞ defined in (1.10) with $f \equiv 0$.*

We end this section with a more classical example of Palais–Smale sequences which holds in the general situation. We let $n \geq 3$ and $\vec{p} = (p_1, \dots, p_n)$, and we assume that $\sum_{i=1}^n 1/p_i > 1$ and $p_+ = p^*$. We let λ be a positive real number, Ω be a bounded, open subset of \mathbb{R}^n , and f be a Caratheodory function in $\Omega \times \mathbb{R}$ satisfying the growth condition (1.3). We let $(r_\alpha)_\alpha$ be a sequence of real numbers converging to p_+ , and we assume that $q < r_\alpha < p_+$ for all α , where q is the real number in (1.3). By standard variational arguments, for any α , we then get the existence of a function u_α in $D^{1,\vec{p}}(\Omega)$ such that there hold $\int_\Omega |u_\alpha|^{r_\alpha} dx = \lambda$ and

$$\sum_{i=1}^n \frac{1}{p_i} \int_\Omega \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i} dx - \int_\Omega F(x, u_\alpha) dx = \min_{\substack{u \in D^{1,\vec{p}}(\Omega) \\ \int_\Omega |u|^{r_\alpha} dx = \lambda}} \left(\sum_{i=1}^n \frac{1}{p_i} \int_\Omega \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx - \int_\Omega F(x, u) dx \right),$$

where $F(x, u) = \int_0^u f(x, s) ds$. In particular, for any α , there exists a positive real number λ_α such that the function u_α is a solution of problem (1.8). The sequence $(u_\alpha)_\alpha$ is a bounded Palais–Smale sequence for the functionals $(I_\alpha)_\alpha$ defined in (1.9).

3. THE ASYMPTOTIC STABILITY OF DOMAINS

This section is devoted to the geometric condition of asymptotic stability of domains which is in the statement of Theorem 1.1. The notion of asymptotically stable domains was introduced in El Hamidi–Vétois [29]. We state the definition below, and we comment this notion in our critical setting $p_+ = p^*$. We first recall that a nonempty subset U of \mathbb{R}^n is said to satisfy the *segment property* if for any point a on ∂U , there exist a neighborhood X_a of a and a nonzero vector σ_a such that $X_a \cap \overline{U} + t\sigma_a \subset U$ for all real numbers t in $(0, 1)$. Adapting classical arguments, as developed, for instance, in Adams–Fournier [1], we get that any nonempty, open subset U of \mathbb{R}^n satisfying the segment property is such that the anisotropic Sobolev space $D^{1,\vec{p}}(U)$ consists of the restrictions to U of functions in $D^{1,\vec{p}}(\mathbb{R}^n)$ with support in \overline{U} . The definition of asymptotically stable domains states as follows.

Definition 3.1. *A nonempty, open subset Ω of \mathbb{R}^n is said to be asymptotically \vec{p} -stable if for any sequence $(\mu_\alpha)_\alpha$ of positive real numbers converging to 0 and for any sequence $(x_\alpha)_\alpha$ in \mathbb{R}^n , the sets $\Omega_\alpha = \tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega)$, where $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}$ is as in (1.5), converge, up to a subsequence, as $\alpha \rightarrow +\infty$, to an open subset U of \mathbb{R}^n which is either empty or satisfies the segment property. The convergence is in the sense that the two following properties hold true:*

- (i) *any compact subset of U is included in Ω_α for α large,*
- (ii) *for any compact $K \subset \mathbb{R}^n$, there holds $|K \cap \Omega_\alpha \setminus U| \rightarrow 0$ as $\alpha \rightarrow +\infty$.*

We use the notation $\Omega_\alpha \rightarrow U$ when (i)–(ii) are satisfied.

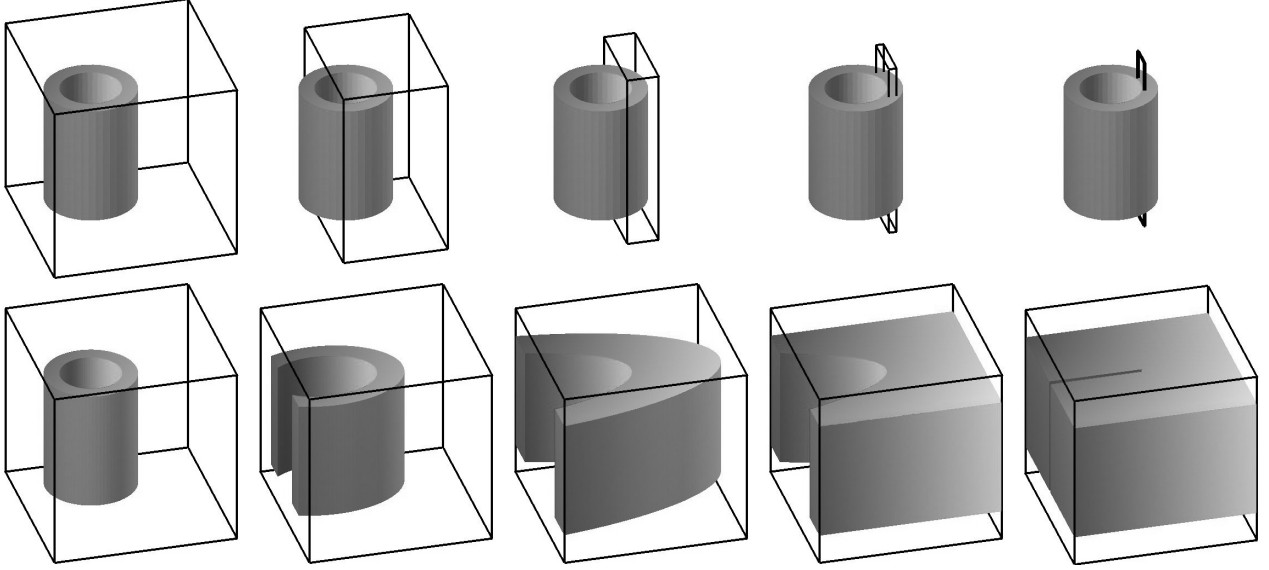


FIGURE 2. Rescaling of an annular cylinder ($n = 3$, $p_1 = 1.1$, $p_2 = 2$, $p_3 = 44/9$). The first line describes the scale in the rescaling. The second line describes the deformation of the domain.

Limits in the sense of (i)–(ii) are unique up to sets of measure zero. Uniqueness, without subtracting sets of measure zero, is recovered when requiring in addition that the limit set is open and satisfies the segment property. The asymptotic stability of domains is a subtle notion. Figure 2 below illustrates what can go wrong with a domain which is not asymptotically

stable. The annular cylinder in Figure 2 bends on itself and converges to a domain of the type $(\mathbb{R}^2 \setminus \mathcal{H}) \times [a, b]$, where $a < b$ and \mathcal{H} is a halfline. In particular, the limit domain does not satisfy the segment property, and thus the annular cylinder is not asymptotically stable.

On the other hand, the ball, illustrated in Figure 1, provides an example of a domain which is asymptotically \vec{p} -stable for any anisotropic configuration \vec{p} . More generally we get the following result.

Theorem 3.2. *Let $n \geq 3$ and $\vec{p} = (p_1, \dots, p_n)$, and assume that $\sum_{i=1}^n 1/p_i > 1$ and $p_+ = p^*$. Then any nonempty, convex, bounded, open subset of \mathbb{R}^n is asymptotically \vec{p} -stable. Moreover, the limit domains U in Definition 3.1 can be chosen to be either empty or convex.*

Proof. We refer to Vétois [67, Theorem 2.1] for the proof of Theorem 3.2 which works the same as in case $p_+ < p^*$. \square

The convexity provides an easy geometric condition for asymptotic stability of domains. Contrary to the case $p_+ < p^*$, there is no regularity type condition. Indeed, there exist domains which are not asymptotically stable for all anisotropic configurations satisfying $p_+ = p^*$. For instance, we can easily show that annular domains of the type $\mathcal{A} = \{x \in \mathbb{R}^n; \ a < |x| < b\}$, where $0 < a < b$, are not asymptotically stable in case $p_+ = p^*$. In order to prove this claim, we let $I_+ = \{i \in \{1, \dots, n\}; \ p_i = p_+\}$, i_0 be such that $p_{i_0} \neq p_+$, $x_0 = (x_1^0, \dots, x_n^0)$ be the point in \mathbb{R}^n such that $x_{i_0}^0 = a$ and $x_n^0 = 0$ for all $i \neq i_0$, and $(\mu_\alpha)_\alpha$ be a sequence of positive real numbers converging to 0. We then get that $\tau_{\mu_\alpha, x_0}^{\vec{p}}(\mathcal{A}) \rightarrow \{x \in \mathbb{R}^n; \ 0 < \sum_{i \in I_+} x_i^2 < b^2 - a^2\}$ as $\alpha \rightarrow +\infty$, and that the limit domain does not satisfy the segment property. It follows that the domain \mathcal{A} , even though being smooth, is not asymptotically stable in case $p_+ = p^*$.

In Theorem 3.3 below, we give a general class of asymptotically stable domains as products of two domains, one of which being asymptotically stable with respect to noncritical directions, and the other satisfying the segment property in critical directions. One can find a detailed discussion in El Hamidi–Vétois [29] and Vétois [67] about asymptotically stable domains with respect to noncritical directions. Our result states as follows.

Theorem 3.3. *Let $n \geq 3$, $\vec{p} = (p_1, \dots, p_n)$, and assume that $\sum_{i=1}^n 1/p_i > 1$, $p_+ = p^*$, $p_{n-n_++1} = \dots = p_n = p_+$, and $p_i < p_+$ for all $i \leq n - n_+$. Let Ω_1 be a nonempty, bounded, open subset of \mathbb{R}^{n-n_+} and Ω_2 be a nonempty, bounded, open subset of \mathbb{R}^{n_+} . Then $\Omega_1 \times \Omega_2$ is asymptotically \vec{p} -stable if and only if Ω_1 is asymptotically \vec{q} -stable, where $\vec{q} = (p_1, \dots, p_{n-n_+})$, and Ω_2 satisfies the segment property.*

Proof of Theorem 3.3. We let $(\mu_\alpha)_\alpha$ be a sequence of positive real numbers converging to 0, $(x_\alpha^1)_\alpha$ be a sequence of points in \mathbb{R}^{n-n_+} , and $(x_\alpha^2)_\alpha$ be a sequence of points in \mathbb{R}^{n_+} . For any α , we let $x_\alpha = (x_\alpha^1, x_\alpha^2)$. We remark that

$$\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega_1 \times \Omega_2) = \tau_{\mu_\alpha, x_\alpha^1}^{\vec{q}}(\Omega_1) \times (\Omega_2 - x_\alpha^2), \quad (3.1)$$

where $\vec{p} = (p_1, \dots, p_n)$ and $\vec{q} = (p_1, \dots, p_{n-n_+})$. We first assume that Ω_1 is asymptotically \vec{q} -stable, and that Ω_2 satisfies the segment property. Passing if necessary to a subsequence, we get that there exists an open subset U_1 of \mathbb{R}^{n-n_+} , either empty or satisfying the segment property, such that $\tau_{\mu_\alpha, x_\alpha^1}^{\vec{q}}(\Omega_1) \rightarrow U_1$ as $\alpha \rightarrow +\infty$ in the sense of Definition 3.1. In case $|x_\alpha^2| \rightarrow +\infty$ as $\alpha \rightarrow +\infty$, we easily get that $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega_1 \times \Omega_2) \rightarrow \emptyset$ as $\alpha \rightarrow +\infty$. Therefore, passing if necessary to another subsequence, we may assume that the sequence $(x_\alpha^2)_\alpha$ converges to a point a_2 in \mathbb{R}^{n_+} . We then claim that $\Omega_2 - x_\alpha^2 \rightarrow \Omega_2 - a_2$ as $\alpha \rightarrow +\infty$, or equivalently that $\Omega_2 - z_\alpha \rightarrow \Omega_2$ as $\alpha \rightarrow +\infty$, where $z_\alpha = x_\alpha^2 - a_2$. For any compact subset K of Ω_2 , we get $d(K, \mathbb{R}^n \setminus (\Omega_2 - z_\alpha)) \geq d(K, \mathbb{R}^n \setminus \Omega_2) - |z_\alpha|$ for all α . Since $z_\alpha \rightarrow 0$ as $\alpha \rightarrow +\infty$, it follows that $\liminf_{\alpha \rightarrow +\infty} d(K, \mathbb{R}^n \setminus (\Omega_2 - z_\alpha)) > 0$, and thus that $K \subset \Omega_2 - z_\alpha$ for α large. Now, we prove that for any compact subset K of \mathbb{R}^{n_+} , there holds $|K \cap (\Omega_2 - z_\alpha) \setminus \Omega_2| \rightarrow 0$ as $\alpha \rightarrow +\infty$. As is easily seen, it suffices to show that for any point a in \mathbb{R}^{n_+} , there exists an open neighborhood X_a of a such that $|X_a \cap (\Omega_2 - z_\alpha) \setminus \Omega_2| \rightarrow 0$ as $\alpha \rightarrow +\infty$. In case a belongs to Ω_2 , for $r > 0$ small, there holds $B_a(r) \subset \Omega_2$, and thus $|B_a(r) \cap (\Omega_2 - z_\alpha) \setminus \Omega_2| = 0$ for all α . In case a belongs to $\mathbb{R}^{n_+} \setminus \overline{\Omega_2}$, for $r > 0$ small, there holds $\overline{B_a(r)} \subset \mathbb{R}^{n_+} \setminus \overline{\Omega_2}$, $B_a(r) \subset \mathbb{R}^{n_+} \setminus (\Omega_2 - z_\alpha)$ for α large, and thus $|B_a(r) \cap (\Omega_2 - z_\alpha) \setminus \Omega_2| = 0$ for α large. Now, we assume that the point a belongs to the boundary of Ω_2 . Since Ω_2 satisfies the segment property, by Maz'ya-Poborchii [49, Section 1.3.1], we get that there exists a Cartesian coordinate system $(\xi_1, \dots, \xi_{n_+})$ of \mathbb{R}^{n_+} , a continuous function $\varphi_a : \mathbb{R}^{n_+-1} \rightarrow \mathbb{R}$, and an open neighborhood X_a of a such that the set $X_a \cap \Omega_2$ consists of the points $(\xi_1, \dots, \xi_{n_+})$ in X_a satisfying $\xi_{n_+} < \varphi_a(\xi_1, \dots, \xi_{n_+-1})$. We then let Y_a be a bounded, open neighborhood of a such that $\overline{Y_a} \subset X_a$. Since $z_\alpha \rightarrow 0$ as $\alpha \rightarrow +\infty$, it follows that, for α large, the set $Y_a \cap (\Omega_2 - z_\alpha) \setminus \Omega_2$ consists of the points $(\xi_1, \dots, \xi_{n_+})$ in Y_a satisfying $\varphi_a(\xi_1, \dots, \xi_{n_+-1}) \leq \xi_{n_+} < \varphi_a(\xi_1 + z_1^\alpha, \dots, \xi_{n_+-1} + z_{n_+-1}^\alpha) - z_{n_+}^\alpha$, where $z_\alpha = (z_1^\alpha, \dots, z_{n_+}^\alpha)$ in the coordinate system $(\xi_1, \dots, \xi_{n_+})$. By the continuity of the function φ_a , we then get $|Y_a \cap (\Omega_2 - z_\alpha) \setminus \Omega_2| \rightarrow 0$ as $\alpha \rightarrow +\infty$. This ends the proof of our claim, namely that $\Omega_2 - x_\alpha^2 \rightarrow \Omega_2 - a_2$ as $\alpha \rightarrow +\infty$. Taking into account (3.1), we then get $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega_1 \times \Omega_2) \rightarrow U_1 \times (\Omega_2 - a_2)$ as $\alpha \rightarrow +\infty$. Moreover, in case U_1 is nonempty, since both U_1 and Ω_2 satisfy the segment property, we get that $U_1 \times (\Omega_2 - a_2)$ satisfies the segment property. Since this holds true for all sequences $(\mu_\alpha)_\alpha$ and $(x_\alpha)_\alpha$, it follows that Ω_1 is asymptotically \vec{p} -stable. Conversely, we assume that $\Omega_1 \times \Omega_2$ is asymptotically \vec{p} -stable. For any α , we let $x_\alpha = (x_\alpha^1, x_\alpha^2)$, where $x_\alpha^2 = 0$ is fixed. Passing if necessary to a subsequence, we get that there exists an open subset U of \mathbb{R}^n , either empty or satisfying the segment property, such that $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega_1 \times \Omega_2) \rightarrow U$ as $\alpha \rightarrow +\infty$. We let $U_1 = \{x \in \mathbb{R}^{n-n_+} ; \exists y \in \Omega_2 \text{ } (x, y) \in U\}$. We claim that $U = U_1 \times \Omega_2$. Clearly, we get $U \subset U_1 \times \Omega_2$. On the other hand, we proceed by contradiction and assume that there exists a point (x_1, x_2) in $U_1 \times \Omega_2$ which does not belong to U . By definition of U_1 , there exists a point y_2 in Ω_2 such that (x_1, y_2) belongs to U . It follows that $\overline{B_{x_1}(\varepsilon)} \times \overline{B_{y_2}(\varepsilon)} \subset U$ for small positive real numbers ε . Moreover, since $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega) \rightarrow U$,

we then get $\overline{B_{x_1}(\varepsilon)} \subset \tau_{\mu_\alpha, x_\alpha^1}^{\vec{q}}(\Omega_1)$ for α large, and we also get $|(B_{x_1}(\varepsilon) \times B_{x_2}(\varepsilon)) \setminus U| = 0$. This is in contradiction with the segment property satisfied by U . This ends the proof of our claim, namely that $U = U_1 \times \Omega_2$. By (3.1) and since $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega) \rightarrow U$, it follows that $\tau_{\mu_\alpha, x_\alpha^1}^{\vec{q}}(\Omega_1) \rightarrow U_1$ as $\alpha \rightarrow +\infty$. Moreover, since U satisfies the segment property, we also get that both U_1 and Ω_2 satisfy the segment property. Since this holds true for all sequences $(\mu_\alpha)_\alpha$ and $(x_\alpha^1)_\alpha$, it follows that Ω_1 is asymptotically \vec{q} -stable. This ends the proof of Theorem 3.3. \square

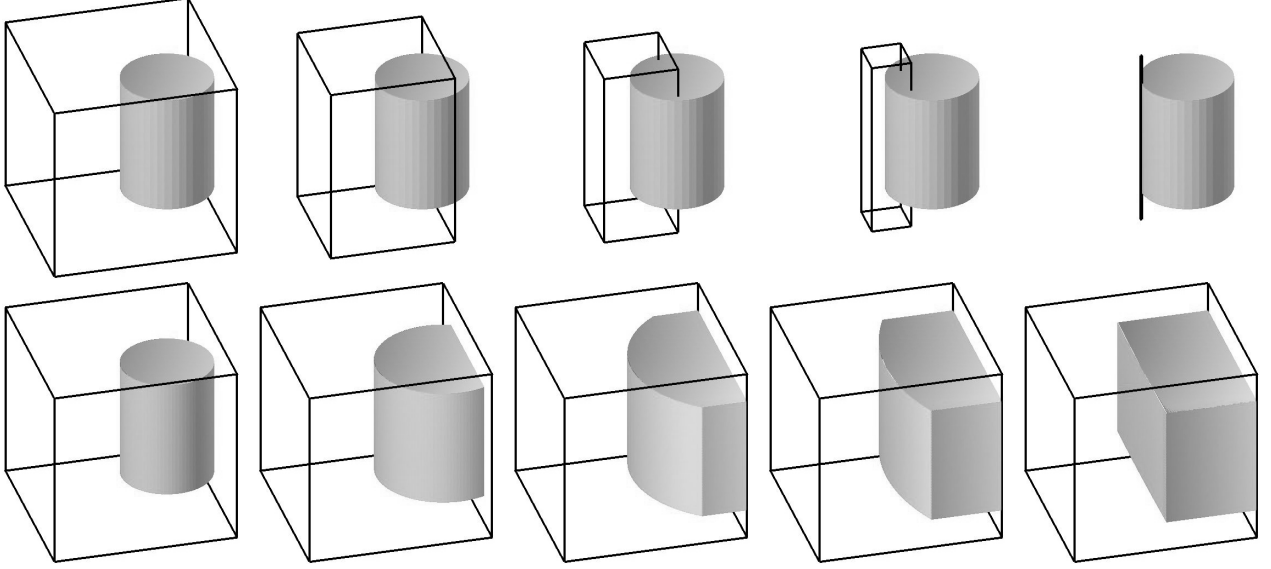


FIGURE 3. Rescaling of a cylinder ($n = 3$, $p_1 = p_2 = 1.5$, $p_3 = 6$). The first line describes the scale in the rescaling. The second line describes the deformation of the domain.

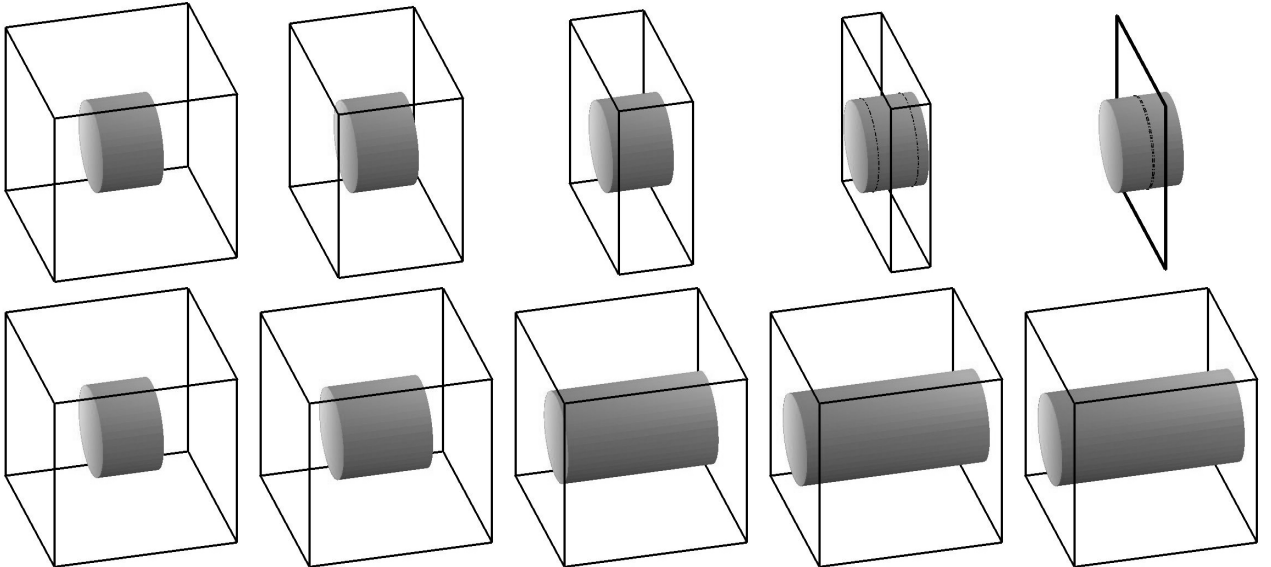


FIGURE 4. Rescaling of $(0, 1)^2 \times \mathbb{B}^2$ ($n = 4$, $p_1 = p_2 = 1.5$, $p_3 = p_4 = 6$, projection onto $\{0\} \times \mathbb{R}^3$). The first line describes the scale in the rescaling. The second line describes the deformation of the domain.

Figures 3 and 4 above illustrate Theorem 3.3 in the cases of two different cylindric domains. In Figure 3, we rescale the cylinder $\mathbb{B}^2 \times (0, 1)$, where \mathbb{B}^2 is the unit two-dimensional ball. The limit domain is of the form $\mathcal{H} \times (0, 1)$, where \mathcal{H} is a halfplane. In Figure 4, we rescale the cylinder $(0, 1)^2 \times \mathbb{B}^2$ (in projection onto $\{0\} \times \mathbb{R}^3$). The limit domain is $\mathbb{R}^2 \times \mathbb{B}^2$.

4. THE CONCENTRATION ON CRITICAL DIRECTIONS

In this section, we prove a concentration result which is the main tool in the proof of Theorem 1.1. We let $(\Omega_\alpha)_\alpha$ be a sequence of nonempty, bounded, open subsets of \mathbb{R}^n , $(\lambda_\alpha)_\alpha$ be a sequence of positive real numbers, and $(r_\alpha)_\alpha$ be a sequence of real numbers in $(1, p_+]$ converging to p_+ . For any α , we define the functional $(J_\alpha)_\alpha$ by

$$J_\alpha(u) = \sum_{i=1}^n \frac{1}{p_i} \int_{\Omega_\alpha} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx - \frac{\lambda_\alpha}{r_\alpha} \int_{\Omega_\alpha} |u|^{r_\alpha} dx \quad (4.1)$$

for all functions u in $D^{1, \vec{p}}(\Omega_\alpha)$. We say that a sequence $(u_\alpha)_\alpha$ is Palais–Smale for the functionals $(J_\alpha)_\alpha$ if there hold $u_\alpha \in D^{1, \vec{p}}(\Omega_\alpha)$, $|J_\alpha(u_\alpha)| \leq C$ for some positive constant C independent of α , and $\|DJ_\alpha(u_\alpha)\|_{D^{1, \vec{p}}(\Omega_\alpha)'} \rightarrow 0$ as $\alpha \rightarrow +\infty$. Moreover, $(u_\alpha)_\alpha$ is said to be bounded if there hold

$$\lambda_\alpha \int_{\Omega_\alpha} |u_\alpha|^{r_\alpha} dx \leq C \quad \text{and} \quad \lambda_\alpha^{\frac{p_+}{p_+ - 1}} \int_{\Omega_\alpha} |u_\alpha|^{\frac{p_+(r_\alpha - 1)}{p_+ - 1}} dx \leq C \quad (4.2)$$

for some positive constant C independent of α . In particular, bounded Palais–Smale sequences for the functionals $(J_\alpha)_\alpha$ are bounded in $D^{1, \vec{p}}(\mathbb{R}^n)$. Our concentration result states as follows.

Proposition 4.1. *Let $n \geq 3$ and $\vec{p} = (p_1, \dots, p_n)$, and assume that $\sum_{i=1}^n 1/p_i > 1$, $p_+ = p^*$, $p_{n-n_++1} = \dots = p_n = p_+$, and $p_i < p_+$ for all $i \leq n - n_+$. Let U be an open subset of \mathbb{R}^n either empty or satisfying the segment property, and $(\Omega_\alpha)_\alpha$ be a sequence of nonempty, bounded, open subsets of \mathbb{R}^n converging to U in the sense of Definition 3.1. Assume that there exists a bounded, open subset V of \mathbb{R}^{n_+} such that the sets U and Ω_α are included in $\mathbb{R}^{n-n_+} \times V$ for all α . Let $(\lambda_\alpha)_\alpha$ be a sequence of positive real numbers converging to $\lambda \geq 0$, and $(r_\alpha)_\alpha$ be a sequence of real numbers in $(1, p_+]$ converging to p_+ . Let $(u_\alpha)_\alpha$ be a bounded Palais–Smale sequence for the functionals $(J_\alpha)_\alpha$ defined in (4.1). Then there exists a function u_∞ in $D^{1, \vec{p}}(U)$ ($u_\infty = 0$ in case $U = \emptyset$) and a finite number k of distinct points $y_j = (y_1^j, \dots, y_{n-n_+}^j)$ in \mathbb{R}^{n-n_+} , $j = 1, \dots, k$, and nonnegative, nontrivial, finite measures ξ_j with support in \overline{V}_{y_j} , $j = 1, \dots, k$, where*

$$\overline{V}_{y_j} = \{(y_1^j, \dots, y_{n-n_+}^j)\} \times \overline{V} \quad (4.3)$$

such that, up to a subsequence, there holds

$$|u_\alpha|^{p_+} \rightharpoonup |u_\infty|^{p_+} + \sum_{j=1}^k \xi_j \quad (4.4)$$

as $\alpha \rightarrow +\infty$ in the sense of measures on compact subsets of \mathbb{R}^n . Moreover, there exists a positive constant $\Lambda_0 = \Lambda_0(\vec{p})$ such that for any $j = 1, \dots, k$, there holds

$$\lambda^{\frac{n+p_+}{p_+}} \xi_j(\overline{V}_{y_j}) \geq \Lambda_0, \quad (4.5)$$

where \overline{V}_{y_j} is as in (4.3). In particular, if $\lambda = 0$, then $k = 0$.

Proof of Proposition 4.1. Passing if necessary to a subsequence, we may assume that the sequence $(u_\alpha)_\alpha$ converges weakly to a function u_∞ in $D^{1, \vec{p}}(\mathbb{R}^n)$ and that $(u_\alpha)_\alpha$ converges to u_∞ almost everywhere in \mathbb{R}^n . Since $\Omega_\alpha \rightarrow U$ as $\alpha \rightarrow +\infty$ in the sense of Definition 3.1, we get

that the support of the function u_∞ is included in \overline{U} . In case $U \neq \emptyset$, since U satisfies the segment property, it follows that the function u_∞ belongs to the anisotropic Sobolev space $D^{1,\vec{p}}(U)$. We fix a positive real number R , and we let $B_0(R)$ be the $(n - n_+)$ -dimensional ball of center 0 and radius R . For any α , we let $v_\alpha = u_\alpha - u_\infty$. By Banach–Alaoglu theorem, since the sequence $(v_\alpha)_\alpha$ is bounded in $D^{1,\vec{p}}(U)$ and since the sets U and Ω_α are included in $\mathbb{R}^{n-n_+} \times V$, where V is bounded, passing if necessary to a subsequence, we may assume that there exist nonnegative, finite measures μ and ν_1, \dots, ν_n on $\overline{B_0(2R)} \times \mathbb{R}^{n_+}$ such that $|v_\alpha|^{p_+} \rightharpoonup \mu$ and $|\partial v_\alpha / \partial x_i|^{p_i} \rightharpoonup \nu_i$ as $\alpha \rightarrow +\infty$ in the sense of measures on $\overline{B_0(2R)} \times \mathbb{R}^{n_+}$, for all $i = 1, \dots, n$. Moreover, the supports of the measures μ and ν_1, \dots, ν_n are included in $\overline{B_0(2R)} \times V$. Since the sequence $(u_\alpha)_\alpha$ is bounded in $L^{p_+}(\mathbb{R}^n)$ and converges to u_∞ almost everywhere in \mathbb{R}^n , by Brezis–Lieb [18], we get

$$\int_U u_\alpha^{p_+} \varphi dx \longrightarrow \int_U u_\infty^{p_+} \varphi dx + \int_{\overline{B_0(2R)} \times V} \varphi d\mu \quad (4.6)$$

as $\alpha \rightarrow +\infty$ for all bounded, measurable functions φ on $\overline{B_0(2R)} \times \mathbb{R}^{n_+}$. Since there holds $|\partial u_\alpha / \partial x_i|^{p_i} \geq |\partial v_\alpha / \partial x_i|^{p_i} - |\partial u_\infty / \partial x_i|^{p_i}$, where $v_\alpha = u_\alpha - u_\infty$ for all α and $i = 1, \dots, n$, we also get

$$\liminf_{\alpha \rightarrow +\infty} \int_U \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i} \varphi dx \geq \int_{\overline{B_0(2R)} \times V} \varphi d\nu_i - \int_U \left| \frac{\partial u_\infty}{\partial x_i} \right|^{p_i} \varphi dx \quad (4.7)$$

as $\alpha \rightarrow +\infty$ for all bounded, measurable functions φ on $\overline{B_0(2R)} \times \mathbb{R}^{n_+}$. Borrowing some ideas in Lions [45, 46] with the tricky difference here that the concentration holds on n_+ -dimensional affine subspaces of \mathbb{R}^n , see the analysis in V\'etois [68], we can prove that there exists an at most countable index set J of distinct points y_j in $\overline{B_0(R)}$, $j \in J$, such that

$$\text{Supp } \mu \cap \overline{B_0(R)} \times V \subset \bigcup_{j \in J} \overline{V}_{y_j}, \quad (4.8)$$

where \overline{V}_{y_j} is as in (4.3). Moreover, since $p_+ = p^*$, by the anisotropic Sobolev inequality in Troisi [65], we get that for any Borelian set A in $\overline{B_0(R)}$, there holds

$$\mu(A \times \overline{V}) \leq \Lambda \prod_{i=1}^n \nu_i(A \times \overline{V})^{\frac{p_+}{n p_i}} \quad (4.9)$$

for some positive constant $\Lambda = \Lambda(\vec{p})$. We then prove (4.5) by using Palais–Smale properties of the sequence $(u_\alpha)_\alpha$. For any nonnegative, smooth function φ with support in $\overline{B_0(2R)} \times \mathbb{R}^{n_+}$, we get

$$\begin{aligned} & \sum_{i=1}^n \left(\int_{\Omega_\alpha} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i} \varphi dx + \int_{\Omega_\alpha} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i-2} \frac{\partial u_\alpha}{\partial x_i} u_\alpha \frac{\partial \varphi}{\partial x_i} dx \right) \\ &= \lambda_\alpha \int_{\Omega_\alpha} |u_\alpha|^{r_\alpha} \varphi dx + D J_\alpha(u_\alpha) \cdot (u_\alpha \varphi) \\ &\leq \lambda_\alpha \left(\int_{\Omega_\alpha} |u_\alpha|^{p_+} \varphi dx + \int_{\Omega_\alpha} \varphi dx \right) + o(1) \end{aligned} \quad (4.10)$$

as $\alpha \rightarrow +\infty$. For any $i = 1, \dots, n$, the functions $|\partial u_\alpha / \partial x_i|^{p_i-2} \partial u_\alpha / \partial x_i$ keep bounded in $L^{p_i/(p_i-1)}(\mathbb{R}^n)$, and thus converge, up to a subsequence, weakly to some function ψ_i in $L^{p_i/(p_i-1)}(\mathbb{R}^n)$ as $\alpha \rightarrow +\infty$. Moreover, for any $i = 1, \dots, n - n_+$, since $p_i < p_+$, by the

compact embeddings in Rákosník [54], we get that the sequence $(u_\alpha)_\alpha$ converges to u_∞ in $L^{p_i}(\text{Supp } \varphi)$ and thus that

$$\int_{\Omega_\alpha} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i-2} \frac{\partial u_\alpha}{\partial x_i} u_\alpha \frac{\partial \varphi}{\partial x_i} dx \longrightarrow \int_U \psi_i u_\infty \frac{\partial \varphi}{\partial x_i} dx \quad (4.11)$$

as $\alpha \rightarrow +\infty$. For any α and any $i = n - n_+ + 1, \dots, n$, we get

$$\left| \int_{\Omega_\alpha} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i-2} \frac{\partial u_\alpha}{\partial x_i} u_\alpha \frac{\partial \varphi}{\partial x_i} dx \right| \leq \left\| \frac{\partial u_\alpha}{\partial x_i} \right\|_{L^{p_i}(\Omega_\alpha)}^{p_i-1} \|u_\alpha\|_{L^{p_i}(\Omega_\alpha)} \left\| \frac{\partial \varphi}{\partial x_i} \right\|_{L^\infty(\mathbb{R}^n)}. \quad (4.12)$$

By (4.6), (4.7), (4.11), and (4.12), passing to the limit into (4.10) as $\alpha \rightarrow +\infty$, we get

$$\begin{aligned} & \sum_{i=1}^n \int_{B_0(2R) \times V} \varphi d\nu_i - \sum_{i=1}^n \int_U \left| \frac{\partial u_\infty}{\partial x_i} \right|^{p_i} \varphi dx + \sum_{i=1}^{n-n_+} \int_U \psi_i u_\infty \frac{\partial \varphi}{\partial x_i} dx \\ & \leq \lambda \left(\int_U |u_\infty|^{p_+} \varphi dx + \int_{B_0(2R) \times V} \varphi d\mu + \int_{\mathbb{R}^n} \varphi dx \right) + C \sum_{i=n-n_++1}^n \left\| \frac{\partial \varphi}{\partial x_i} \right\|_{L^\infty(\mathbb{R}^n)} \end{aligned} \quad (4.13)$$

for some positive constant C independent of φ . We claim that

$$\sum_{i=1}^n \int_U \psi_i u_\infty \frac{\partial \varphi}{\partial x_i} dx + \sum_{i=1}^n \int_U \psi_i \frac{\partial u_\infty}{\partial x_i} \varphi dx = \lambda \int_U |u_\infty|^{p_+} \varphi dx. \quad (4.14)$$

Since the function u_∞ belongs to $D^{1,\vec{p}}(U)$ and since $\Omega_\alpha \rightarrow U$ as $\alpha \rightarrow +\infty$ in the sense of Definition 3.1, we get that there exist smooth functions b_α with compact support in Ω_α converging to u_∞ as $\alpha \rightarrow +\infty$ in $D^{1,\vec{p}}(\mathbb{R}^n)$, and thus also in $L^{p_+}(\mathbb{R}^n)$ by the continuity of the embedding of $D^{1,\vec{p}}(\mathbb{R}^n)$ into $L^{p_+}(\mathbb{R}^n)$. Since the sequence $(u_\alpha)_\alpha$ is Palais–Smale for the functionals $(J_\alpha)_\alpha$ defined in (4.1), it follows that

$$\begin{aligned} & \sum_{i=1}^n \int_{\Omega_\alpha} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i-2} \frac{\partial u_\alpha}{\partial x_i} b_\alpha \frac{\partial \varphi}{\partial x_i} dx + \sum_{i=1}^n \int_{\Omega_\alpha} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i-2} \frac{\partial u_\alpha}{\partial x_i} \frac{\partial b_\alpha}{\partial x_i} \varphi dx \\ & = \lambda_\alpha \int_{\Omega_\alpha} |u_\alpha|^{r_\alpha-2} u_\alpha b_\alpha \varphi dx + D J_\alpha(u_\alpha) \cdot (b_\alpha \varphi) \\ & = \lambda_\alpha \int_{\Omega_\alpha} |u_\alpha|^{r_\alpha-2} u_\alpha b_\alpha \varphi dx + o(1) \end{aligned} \quad (4.15)$$

as $\alpha \rightarrow +\infty$. By (4.2), we get that the functions $\lambda_\alpha |u_\alpha|^{r_\alpha-2} u_\alpha$ keep bounded in $L^{p_+/(p_+-1)}(\mathbb{R}^n)$. Moreover the functions $\lambda_\alpha |u_\alpha|^{r_\alpha-2} u_\alpha$ converge, up to a subsequence, almost everywhere to $\lambda |u_\infty|^{p_+-2} u_\infty$ in \mathbb{R}^n as $\alpha \rightarrow +\infty$. By standard integration theory, it follows that the functions $\lambda_\alpha |u_\alpha|^{r_\alpha-2} u_\alpha$ converge weakly to $\lambda |u_\infty|^{p_+-2} u_\infty$ in $L^{p_+/(p_+-1)}(\mathbb{R}^n)$. Passing to the limit into (4.15) as $\alpha \rightarrow +\infty$, we get (4.14). Increasing if necessary the constant C in (4.13), it follows from (4.14) that

$$\begin{aligned} & \sum_{i=1}^n \int_{B_0(2R) \times V} \varphi d\nu_i - \sum_{i=1}^n \int_U \left| \frac{\partial u_\infty}{\partial x_i} \right|^{p_i} \varphi dx - \sum_{i=1}^n \int_U \psi_i \frac{\partial u_\infty}{\partial x_i} \varphi dx \\ & \leq \lambda \left(\int_{B_0(2R) \times V} \varphi d\mu + \int_{\mathbb{R}^n} \varphi dx \right) + C \sum_{i=n-n_++1}^n \left\| \frac{\partial \varphi}{\partial x_i} \right\|_{L^\infty(\mathbb{R}^n)}. \end{aligned} \quad (4.16)$$

We let η be a smooth cutoff function on \mathbb{R}^{n-n_+} such that $\eta = 1$ in $B_0(1)$, $0 \leq \eta \leq 1$ in $B_0(2) \setminus B_0(1)$, and $\eta = 0$ in $\mathbb{R}^{n-n_+} \setminus B_0(2)$. For any point $y = (y_1, \dots, y_{n-n_+})$ in $\overline{B_0(R)}$ and for any positive real number ε , we let $\varphi_{\varepsilon,y}$ be the function defined on \mathbb{R}^n by

$$\varphi_{\varepsilon,y}(x_1, \dots, x_n) = \eta\left(\frac{1}{\varepsilon}(x_1 - y_1), \dots, \frac{1}{\varepsilon}(x_{n-n_+} - y_{n-n_+})\right).$$

Plugging $\varphi = \varphi_{\varepsilon,\sigma,y}$ into (4.16), and passing to the limit as $\varepsilon \rightarrow 0$, we get

$$\sum_{i=1}^n \nu_i(\overline{V}_y) \leq \lambda \mu(\overline{V}_y), \quad (4.17)$$

where \overline{V}_y is as in (4.3). By (4.9) and (4.17), we get that there holds either

$$\mu(\overline{V}_y) = 0 \quad \text{or} \quad \lambda \mu(\overline{V}_y)^{\frac{p_+}{n+p_+}} \geq \Lambda^{\frac{-n}{n+p_+}} \quad (4.18)$$

for all points y in \mathbb{R}^{n-n_+} . In particular, since the measure μ is finite, it follows from (4.18) that the index set J in (4.8) is finite. Passing to the limit as $R \rightarrow +\infty$, by (4.6) and (4.8), we get the decomposition (4.4). Finally, (4.5) follows from (4.18). \square

5. PROOF OF THE MAIN RESULT

In this section, we prove Theorem 1.1 by using Proposition 4.1 and Proposition 5.1 below.

Proposition 5.1. *Let $n \geq 3$ and $\vec{p} = (p_1, \dots, p_n)$, and assume that $\sum_{i=1}^n 1/p_i > 1$ and $p_+ = p^*$. Then there exists a positive constant $E_0 = E_0(\vec{p})$ such that for any positive real number λ and any \vec{p} -bubble $(B_\alpha)_\alpha$ of multiplier λ , there holds*

$$E(B_\alpha) \geq E_0 \lambda^{-n/p_+}, \quad (5.1)$$

where $E(B_\alpha)$ is as in (1.7).

Proof of Proposition 5.1. Without loss of generality, we may assume that there exists an index n_+ such that $p_{n-n_++1} = \dots = p_n = p_+$ and $p_i < p_+$ for all $i \leq n - n_+$. We let λ be a positive real number and $(B_\alpha)_\alpha$ be a \vec{p} -bubble of profile u and multiplier λ . Since $p_+ = p^*$, by the anisotropic Sobolev inequality in Troisi [65], we get

$$\int_{\mathbb{R}^n} |u|^{p_+} dx \leq \Lambda \prod_{i=1}^n \left(\int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx \right)^{\frac{p_+}{n p_i}}$$

for some positive constant Λ independent of u . By Young's inequality, it follows that for any positive real number ε , there holds

$$\begin{aligned} \int_{\mathbb{R}^n} |u|^{p_+} dx &\leq \frac{\Lambda}{n} \left((n - n_+) \varepsilon^{\frac{-n_+}{n-n_+}} \prod_{i=1}^{n-n_+} \left(\int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx \right)^{\frac{p_+}{(n-n_+)p_i}} \right. \\ &\quad \left. + \varepsilon \sum_{i=n-n_++1}^n \int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx \right). \end{aligned} \quad (5.2)$$

On the other hand, since u is a solution of problem (1.6), we get

$$\sum_{i=1}^n \int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx = \lambda \int_{\mathbb{R}^n} |u|^{p_+} dx. \quad (5.3)$$

Taking $\varepsilon = \frac{n}{\Lambda\lambda}$, since $\sum_{i=1}^{n-n_+} \frac{1}{p_i} = \frac{n-n_++p_+}{p_+}$, it follows from (5.2) and (5.3) that

$$\sum_{i=1}^{n-n_+} \int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx \leq \left(\frac{\Lambda\lambda}{n} \right)^{\frac{n}{n-n_+}} (n-n_+) \left(\sum_{i=1}^{n-n_+} \int_{\mathbb{R}^n} \left| \frac{\partial u}{\partial x_i} \right|^{p_i} dx \right)^{\frac{n-n_++p_+}{n-n_+}}.$$

We then easily get (5.1). \square

Proof of Theorem 1.1. Without loss of generality, we may assume that there exists an index n_+ such that $p_{n-n_++1} = \dots = p_n = p_+$ and $p_i < p_+$ for all $i \leq n - n_+$. We let $(u_\alpha)_\alpha$ be a bounded Palais–Smale sequence for the functionals $(I_\alpha)_\alpha$ defined in (1.9). Passing if necessary to a subsequence, we may assume that $(u_\alpha)_\alpha$ converges weakly to a function u_∞ in $D^{1,\vec{p}}(\Omega)$. Proceeding in the same way as in El Hamidi–Vétois [29], we can prove that u_∞ is a solution of problem (1.2). By an easy adaptation of the argument in Brézis–Lieb [18] and by the growth condition (1.3), we also get that, up to a subsequence, $(u_\alpha^0)_\alpha$, where $u_\alpha^0 = u_\alpha - u_\infty$, is Palais–Smale for the functionals $(J_\alpha)_\alpha$ defined in (4.1) with $\lambda_\alpha = \lambda$ and $\Omega_\alpha = \Omega$ for all α , and that there holds $J_\alpha(u_\alpha^0) = I_\alpha(u_\alpha) - I_\alpha(u_\infty) + o(1)$ as $\alpha \rightarrow +\infty$. If the sequence $(u_\alpha)_\alpha$ converges strongly, up to a subsequence, to the function u_∞ in $D^{1,\vec{p}}(\Omega)$, then we get (1.11) and (1.12) with $k = 0$. From now on, subtracting if necessary the weak limit u_∞ , we may assume that the sequence $(u_\alpha)_\alpha$ converges weakly but not strongly to 0 in $D^{1,\vec{p}}(\Omega)$, and that $(u_\alpha)_\alpha$ is Palais–Smale for the functionals $(J_\alpha)_\alpha$ with $\lambda_\alpha = \lambda$ and $\Omega_\alpha = \Omega$ for all α . In particular, passing if necessary to a subsequence, we get

$$\liminf_{\alpha \rightarrow +\infty} \sum_{i=1}^n \int_{\Omega} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i} dx > 0.$$

By Palais–Smale properties and by Hölder’s inequality, it follows that

$$\sum_{i=1}^n \int_{\Omega} \left| \frac{\partial u_\alpha}{\partial x_i} \right|^{p_i} dx = \int_{\Omega} |u_\alpha|^{r_\alpha} dx + o(1) \leq |\Omega|^{\frac{p_+-r_\alpha}{p_+}} \left(\int_{\Omega} |u_\alpha|^{p_+} dx \right)^{\frac{r_\alpha}{p_+}} + o(1)$$

as $\alpha \rightarrow +\infty$, and thus that

$$\liminf_{\alpha \rightarrow +\infty} \int_{\Omega} |u_\alpha|^{p_+} dx > 0. \quad (5.4)$$

For any α , we then define the concentration function $Q_\alpha : \mathbb{R}_+ \rightarrow \mathbb{R}_+$ by

$$Q_\alpha(s) = \max_{y \in \overline{\Omega}} \int_{\mathcal{P}_y^{\vec{p}}(s)} |u_\alpha|^{p_+} dx,$$

where

$$\mathcal{P}_y^{\vec{p}}(s) = \left\{ (x_1, \dots, x_n) \in \mathbb{R}^n; |x_i - y_i| < s^{\frac{p_+-p_i}{p_i}} \quad \forall i \in \{1, \dots, n - n_+\} \right\}$$

for any positive real number s and for any point $y = (y_1, \dots, y_n)$ in \mathbb{R}^n . By (5.4) and since the domain Ω is bounded, we get the existence of two positive real numbers s_0 and δ_0 such that there holds $Q_\alpha(s_0) > \delta_0$ for all α . By the continuity of the functions Q_α , it follows that there exists a sequence $(\mu_\alpha)_\alpha$ of real numbers in $(0, s_0)$ such that there holds $Q_\alpha(\mu_\alpha) = \delta_0$ for all α . We let x_α be a point in $\overline{\Omega}$ for which $Q_\alpha(\mu_\alpha)$ is reached, so that

$$\max_{y \in \overline{\Omega}} \int_{\mathcal{P}_y^{\vec{p}}(\mu_\alpha)} |u_\alpha|^{p_+} dx = \int_{\mathcal{P}_{x_\alpha}^{\vec{p}}(\mu_\alpha)} |u_\alpha|^{p_+} dx = \delta_0 \quad (5.5)$$

for all α . We claim that if the constant δ_0 is chosen small enough, then the sequence $(\mu_\alpha)_\alpha$ converges to 0. Indeed, if not the case, then for any $\varepsilon > 0$, there exists $s_\varepsilon > 0$ such that for any α and any point y in $\bar{\Omega}$, there holds

$$\int_{\mathcal{P}_y^{\vec{p}}(s_\varepsilon)} |u_\alpha|^{p_+} dx \leq \varepsilon. \quad (5.6)$$

By Proposition 4.1 with $\lambda_\alpha = \lambda$ and $\Omega_\alpha = \Omega$ for all α (in this case, we can easily drop the segment condition), it follows from (5.6) that the sequence $(u_\alpha)_\alpha$ converges in fact strongly to 0 in $L^{p_+}(\Omega)$. There is a contradiction with (5.4), and this proves our claim, namely that if the constant δ_0 is chosen small enough, then the sequence $(\mu_\alpha)_\alpha$ converges to 0. For any α , we then define the function \tilde{u}_α by

$$\tilde{u}_\alpha = \mu_\alpha u_\alpha \circ (\tau_{\mu_\alpha, x_\alpha}^{\vec{p}})^{-1},$$

where $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}$ is as in (1.5). As well as $(u_\alpha)_\alpha$, the sequence $(\tilde{u}_\alpha)_\alpha$ is Palais–Smale for the functionals $(J_\alpha)_\alpha$ with $\lambda_\alpha = \lambda \mu_\alpha^{p_+ - r_\alpha}$ and $\Omega_\alpha = \tau_{\mu_\alpha, x_\alpha}^{\vec{p}}(\Omega)$ for all α . Passing if necessary to a subsequence, we may assume that the sequence $(\lambda_\alpha)_\alpha$ converges to a nonnegative real number $\tilde{\lambda}$. By an easy change of variable, we also find

$$\lambda_\alpha \int_{\Omega_\alpha} |\tilde{u}_\alpha|^{r_\alpha} dx = \lambda \int_{\Omega} |u_\alpha|^{r_\alpha} dx \quad (5.7)$$

and

$$\lambda_\alpha^{\frac{p_+}{p_+ - 1}} \int_{\Omega_\alpha} |\tilde{u}_\alpha|^{\frac{(r_\alpha - 1)p_+}{p_+ - 1}} dx = \lambda^{\frac{p_+}{p_+ - 1}} \int_{\Omega} |u_\alpha|^{\frac{(r_\alpha - 1)p_+}{p_+ - 1}} dx. \quad (5.8)$$

It follows from (5.7) and (5.8) that $(\tilde{u}_\alpha)_\alpha$ is a bounded Palais–Smale sequence for the functionals $(J_\alpha)_\alpha$. Passing if necessary to a subsequence, since the domain Ω is asymptotically \vec{p} -stable, we may assume that there exists an open subset U , either empty or satisfying the segment property, such that $\Omega_\alpha \rightarrow U$ as $\alpha \rightarrow +\infty$ in the sense of Definition 3.1. Moreover, since Ω is bounded and since the maps $\tau_{\mu_\alpha, x_\alpha}^{\vec{p}}$ do not rescale the domain in critical directions, we get that the sets Ω_α and U are included in $\mathbb{R}^{n-n_+} \times V$ for some bounded, open subset V independent of α . By Proposition 4.1, we get the existence of a function \tilde{u} in $D^{1, \vec{p}}(U)$ ($\tilde{u} = 0$ in case $U = \emptyset$) and a finite number k of distinct points $y_j = (y_1^j, \dots, y_{n-n_+}^j)$ in \mathbb{R}^{n-n_+} , $j = 1, \dots, k$, and nonnegative finite measures ξ_j with support in \bar{V}_{y_j} , $j = 1, \dots, k$, such that, up to a subsequence, there holds

$$|\tilde{u}_\alpha|^{p_+} \rightharpoonup |\tilde{u}|^{p_+} + \sum_{j=1}^k \xi_j$$

as $\alpha \rightarrow +\infty$ in the sense of measures on compact subsets of \mathbb{R}^n . If $\tilde{\lambda} = 0$, then $k = 0$. Otherwise, in case $\tilde{\lambda} > 0$, we claim that if the constant δ_0 is chosen small enough, then $k = 0$. We assume by contradiction that $k \neq 0$. By (5.5) and by an easy change of variable, for any α and $j = 1, \dots, k$, we get

$$\int_{\mathcal{P}_{y_j}^{\vec{p}}(1)} |\tilde{u}_\alpha|^{p_+} dx \leq \delta_0. \quad (5.9)$$

Since there holds $\bar{V}_{y_j} \subset \mathcal{P}_{y_j}^{\vec{p}}(1)$, passing to the limit into (5.9) as $\alpha \rightarrow +\infty$, it follows that

$$\int_{\mathcal{P}_{y_j}^{\vec{p}}(1)} |\tilde{u}|^{p_+} dx + \xi_j(\bar{V}_{y_j}) \leq \delta_0. \quad (5.10)$$

On the other hand, by (4.5), we get $\xi_j(\bar{V}_{y_j}) \geq \Lambda_0 \tilde{\lambda}^{-(n+p_+)/p_+}$. Since there hold $\mu_\alpha^{p_+-r_\alpha} \leq 1$ for α large and $\lambda \mu_\alpha^{p_+-r_\alpha} \rightarrow \tilde{\lambda}$ as $\alpha \rightarrow +\infty$, we get $\tilde{\lambda} \leq \lambda$, and thus $\xi_j(\bar{V}_{y_j}) \geq \Lambda_0 \lambda^{-(n+p_+)/p_+}$. There is a contradiction with (5.10) in case $\delta_0 < \Lambda_0 \lambda^{-(n+p_+)/p_+}$. This ends the proof of our claim, namely that if the constant δ_0 is chosen small enough, then $k = 0$. By Radon's theorem, it follows that the sequence $(\tilde{u}_\alpha)_\alpha$ converges to \tilde{u} in $L_{\text{loc}}^{p_+}(\mathbb{R}^n)$. By (5.5) and by an easy change of variable, for any α , we get

$$\int_{\mathcal{P}_0^{\vec{p}}(1)} |\tilde{u}_\alpha|^{p_+} dx = \delta_0. \quad (5.11)$$

Passing to the limit into (5.11) as $\alpha \rightarrow +\infty$, it follows that

$$\int_{\mathcal{P}_0^{\vec{p}}(1)} |\tilde{u}|^{p_+} dx = \delta_0,$$

and thus that the function \tilde{u} is not identically zero. In particular, the domain U is not empty. The end of the proof follows Struwe [62] (see El Hamidi-Vétois [29] for the case of the anisotropic Laplace operator with $p_+ < p^*$), and we sketch it for sake of completeness. We prove that the function \tilde{u} is a solution of problem (1.6) with $\lambda = \tilde{\lambda}$, so that we can define the \vec{p} -bubble $(B_\alpha^1)_\alpha$, $B_\alpha^1 = \mu_\alpha^{-1} \tilde{u} \circ \tau_{\mu_\alpha, x_\alpha}^{\vec{p}}$. We then prove that there exists a sequence $(R_\alpha^1)_\alpha$ converging strongly to 0 in $D^{1, \vec{p}}(\mathbb{R}^n)$ such that, up to a subsequence, $(u_\alpha^1)_\alpha$, where $u_\alpha^1 = u_\alpha - B_\alpha^1 + R_\alpha^1$, is Palais-Smale for the functionals $(J_\alpha)_\alpha$ and satisfies $J_\alpha(u_\alpha^1) = J_\alpha(u_\alpha) - E(B_\alpha^1) + o(1)$ as $\alpha \rightarrow +\infty$. We iterate the above arguments in order to construct the \vec{p} -bubbles $(B_\alpha^1)_\alpha, \dots, (B_\alpha^k)_\alpha$. Our induction has to stop for some finite number k since, by Proposition 5.1, the energy of \vec{p} -bubbles is bounded from below by a positive constant which only depends on λ and on the anisotropic configuration \vec{p} . We finally obtain (1.11) and (1.12). Moreover, in case the functions u_α are nonnegative, their weak limit u_∞ is nonnegative, and by considering the functions $\max(u_\alpha^j - B_\alpha^j, 0)$, we prove that the \vec{p} -bubbles $(B_\alpha^1)_\alpha, \dots, (B_\alpha^k)_\alpha$ are also nonnegative (see [29]). This ends the proof of Theorem 1.1. \square
